7:30 am – 8:30 am (bus will depart at 8:30 am).	Begin boarding the bus and get ready for a busy and exciting day. Tours will include the Gold Dredge #8, The Permafrost Tunnel, and Fort Knox Gold Mine.
8:30 am – 9:15 am (45 mins)	Transporting to Fox Alaska to tour the Trans Alaska Pipeline (TAPS) and board the train for a fantastic tour of the historic Gold Dredge #8 (seriously, locals and everyone else love this tour. It's not a boring tourist trap).
9:30 am – 11:30 am (2 hr)	Gold Dredge #8 Tour. Cookies, cocoa, coffee, and tea available complimentary on this trip.
11:30 am – 12:00 pm	Transporting over to the Alaska Corps of Engineers Permafrost Tunnel.
12:00 – 2:00 pm Three groups to be Taken. 2 at 45 minutes and 1 at 30 minutes	Tour of the tunnel. There will be groups of 3 that will have 45 minutes to tour the tunnel. Please dress accordingly. The tunnel is very cold. During the rotation time folks can eat their lunch and socialize.
2:00 pm – 2:15 pm	Board bus for a tour of Kinross Fort Knox Gold Mine. Be prepared to be wowed. This beautiful Gold Mine is a huge part of the Fairbanks culture and is a great piece of the Golden Heart City. It will take approximately 30-45 minutes to wind your way into the hills to the Gold Mine. Arrival is estimated to be 3:00pm.
3:00 pm – 5:00 pm	Touring the Kinross Fort Knox Gold Mine Hopefully you brought your boots, because the safety of visitors and guest is taken very seriously here and is no joking matter. Long pants and appropriate footwear that fully covers your foot are required. You will be at Alaska's largest open pit gold mine, which that has numerous large and heavy equipment. Be aware of your surroundings, wear proper and adequate safety Personal Protective Equipment (PPE), and stay with your guide . Other safety PPE such as hard hat, safety vests, and eye protection will be provided by the mine. Safety is ALWAYS First!!
